A PERSONAL LAWSUIT.**

**The COVID-19 “vaccinations” are NOT approved vaccines The injections include substances that have  
been temporarily “authorized” by the FDA for emergency use only. An Emergency Use Authorization  
(EUA) is NOT the same as an approved drug or treatment.**

## **TITLE 18, U.S.C., SECTION 242**

“Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, ... shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both;

**I WILL CERTAINLY COMPLY WITH ANY LEGITIMATE LAW ENFORCEMENT OFFICER WHO IS  
LEGALLY AUTHORIZED TO ENFORCE THE LAW, HOWEVER...**

**NO LAW EXISTS THAT OVERRIDES THE CONCEPT OF INFORMED CONSENT.**

**NO LEGAL AUTHORITY EXISTS TO MANDATE MY ACCEPTANCE OF AN EXPERIMENTAL  
VACCINE OR TO RESTRICT MY FREEDOMS IN ANY WAY IF I HAVE CHOSEN TO MAINTAIN  
AUTONOMY OVER MY OWN BODY BY REFUSING TO PARTICIPATE IN MEDICAL EXPERIMENTS.**

**IF YOU ATTEMPT TO RESTRICT ANY OF MY CONSTITUTIONALLY GUARANTEED FREEDOMS  
BY CLAIMING TO BE ACTING UNDER LEGAL AUTHORITY OF ANY KIND, THEN YOU MAY BE  
COMMITTING A CRIME “UNDER THE COLOR OF LAW.”**

**ANY SUCH ACTION ON YOUR PART MAY SUBJECT YOU TO A PERSONAL LAWSUIT.**

**CLAIMING THAT YOU ARE “DOING AS YOU ARE TOLD” IS NOT A VALID DEFENSE.**
